Roll call was initiated after the pledge of allegiance. All members were present except Mr. Leak.

#### Comments & Questions

Ms. Farran asked if any guest had any comments or questions. Kay Barnum, 3520 Oakwood Drive stated her concern regarding the pool. Discussion followed.

# Fire Department

Chief Vanderbur, Edgewood Fire Department reported that there were ten runs. Nine runs were medical and one was a fire run.

## Police Department

Marshal Ellingwood reported on the case reports for January. There were 145 incident/case reports in the month of January. There were 35 arrests/citations broken down as follows: Captain Briggs 12; Officer Naselroad 9; Officer Shoppell 11; and Officer Auckerman 3. The reserve officer, Officer Robertson worked 21 hours. Part-time Officer, Officer Auckerman worked 40 hours, and the two Reserve Officers in training worked 18 hours. Marshal Ellingwood informed the council and guests that Randall Auckerman, who is currently a part-time Edgewood Police Officer will become full-time March 1, 2017. The Town of Orestes is interested in purchasing the 2012 Dodge Charger from the Police Department in June 2017 for \$6,000. Discussion followed. Mrs. Norrick made a motion to approve the sale of the police car. Mrs. Armington seconded the motion. All members voting aye, motion carried.

## **Town Engineer's Report**

Mr. Servies reported that he had tried to obtain three bids for the work that needs to be done in Long Acres and Edgewood Place, unfortunately no bids were presented. Mr. Servies stated that he would try again to obtain bids. Discussion Followed.

## Water Operator's Report

Mr. Thomas Brewer, Edgewood Water Operator reported on the various activity at the water plant. Mr. Brewer showed the council and guests some of the pieces that ended up going into the lift station. Discussion followed.

The total amount of the agreement for 911 Fire Service for 2017 is \$10,983.48. There will be two installments of \$5,491.74. Discussion followed. Mrs. Norrick made a motion to approve the agreement.
