Fire Department

Water Operator's Report

Mr. Thomas Brewer, Edgewood Water Operator reported on the various activity at the water plant. The water main leak on Maple Road had been successfully repaired. The brine container was rebuilt and is not ready to spread brine on the roads. The water department has been able to provide cleaner and clearer water to the residents.

Police Department

Marshal Ellingwood reported that there were 132 incident/case reports in the month of December. There were 15 arrests/citations broken down as follows: Captain Briggs 5 and Officer Naselroad 10. The reserve officers, Officer Robertson worked 32 hours and Officer Lehman worked 40 hours; Part-time Officers worked 58 hours.
