Roll call was initiated after the pledge of allegiance. All members were present except Mr. Gunter.

### **Fire Department**

Chief Vanderbur, Edgewood Fire Department reported on the activity for the month of October. There were ten runs. Chief Vanderbur reported about various fire department activity.

**Approval of the Minutes from the October 21, 2019 Council Meeting**


